5. Mayor's communication

5.1 Mayor's Report

Australian of the Year Luncheon 2021

It was fantastic meeting Dr James Mueke who is the 2020 Australian of the Year for his work raising awareness of type 2 diabetes and its links to blindness. Dr Mueke gave a passionate speech at the Australian of the Year Luncheon at the Adelaide Convention Centre.

This was a timely event to attend as I commence my role as a volunteer board member with the Australia Day Council SA.

Aldinga Washpool

The state government will protect our unique Aldinga Washpool forever by proclaiming it as a conservation park.

This is a huge win for the Onkaparinga region and anyone who loves the Washpool area.

The City of Onkaparinga has been advocating strongly on behalf of the community for many years to secure the future of the Washpool and surrounding land.

Many thanks to the tireless efforts of local community and environment groups who've supported on this journey, providing their energy and support through advocacy and onground conservation activities.

Thanks to Minister David Speirs MP for this decision which represents a strong commitment to conservation, culture and the environment.



The Aldinga Washpool area can now continue providing environmental, cultural, social benefits for generations to come. However there are still areas of land adjacent the Washpool zone that are marked as "subject to further consideration for inclusion in the conservation park" on the state government's proposed park map.

Both Council and our community agree that all land in the area should be included in the park, including these zones.

Given the cultural significance of the Washpool, the City of Onkaparinga also recognises the important opportunity the proclamation of the park presents for co-management with Kaurna representatives.

Through their community co-design process, we urge the state government to discuss the potential of involving Traditional Owners in the management of the park. We look forward to working alongside all stakeholders involved in the co-design process in shaping a management plan for the area.

16 new netball courts for the South

Earlier this year, Council received \$1.7M from stage 1 of the Federal Government's Local Roads and Community Infrastructure stimulus program to enable the reconstruction of the existing 12 courts at Southern United Netball Association (SUNA) and installation of match standard lights.

Last month Council approved \$289,000 in additional funding along with SUNA's \$300,000 contribution to enable construction of an additional six courts and associated match standard lighting.

This investment is timely given the significant growth in netball participation we are seeing across the City of Onkaparinga which is fantastic to support the health, wellbeing, confidence and community connections for netball players and their families.

Aldinga Suburban Neighbourhood Development Plan Amendment

On 18 June 2021, we received a letter dated 16 June 2021 from the Deputy Premier and Minister for Planning and Local Government, Vickie Chapman MP, advising that the Aldinga Suburban Neighbourhood Development Plan Amendment (DPA) has been approved.

We made a submission to the State Planning Commission (the Commission) on the DPA, as approved by Council's Strategic Directions Committee at the 6 April 2021 <u>meeting</u>. Refer to the meeting agenda and minutes for details.

We acknowledge the concerns raised by both the Friends of Willunga Basin and Friends of Port Willunga, that the consultation for this DPA under the old planning system (Development Act) and finalising it under the new planning system (PDI Act) was confusing. We also share their concerns regarding residential density and our submission raised concerns on lack of density control (and noting reference to medium and high density), buildings up to three levels or 12m and the allowable floor area for non-residential development.

When we presented to the Commission at the public meeting on 7 April 2021, we also raised two other key matters being our preference for the Master Planned Township Zone and the need for a Concept Plan to reflect the Aldinga Structure Plan. Our preference for the Master Planned Township Zone was due to its focus toward lower density residential development, rather than allowing for medium to high densities as envisaged under the Master Planned Neighbourhood Zone.

Although the Minister has now approved the DPA with the Master Planned Neighbourhood Zone, the Concept Plan has been included which we consider to be an important, partial win, to set the foundation for the development of the land. We continue to have concern with the



lack of clarity on density controls and what may be proposed in a future land division application.

We do, however, note that the <u>Housing Analysis Report</u> provided with the Aldinga Structure Plan indicates a preferred development scenario for 'residential allotments generally in the range of 300m² to 600m² but with an appetite for smaller detached dwelling product in selected locations where specific house and land design solutions are delivered to a market seeking greater affordability and an alternative lifestyle outcome. Based on the report commentary, it would seem that most future housing would be accommodated on allotments not dissimilar to existing houses throughout Aldinga Beach. With the small lot/medium density housing, the report indicates they would be located close to transport and services and directed for people seeking affordable housing, retirement living and lifestyle choice. A major consideration for such housing forms is they need to be well designed; an outcome council will continue push for.

Whilst density is important and it plays a role in setting the future character of an area, we are also mindful of the need for more sustainable development, regardless of density outcomes. One key element is allotment orientation supported by house orientation, design and material selections, and open spaces for trees (including street trees), and water harvesting and reuse. We understand the community have the same aspirations for the site.

Council staff have been advocating to Renewal SA, as the landowners, for sustainable development outcomes, and we will continue to when assessing any future land division and housing applications.

Disposal of sharps in public areas

Last month we received reports of syringes being found nearby playgrounds at Minkarra Park, Flagstaff Hill and Warsaw Reserve, Hackham West.

All data regarding the collection of inappropriately disposed of syringes from our parks and reserves, in addition to the data of syringes removed from our public toilet facilities, is collated and utilised to identify 'hot spot' or 'at risk locations' for discarded syringes. This data is collected as part of our programmed visits for parks, garden beds, playgrounds, public toilets and building maintenance services. Syringe disposal containers installed in public toilets are checked daily.

At locations where higher numbers of syringes are collected, this data is forwarded onto SAPol's District Policing Teams for their information and investigation. It is also passed onto maintenance staff to ensure they are extra vigilant in looking for discarded syringes in these locations when on site. Although the numbers found at Minkarra Park and Warsaw Reserve are very low, we have added these sites to our list of at-risk locations.

We also undertake Crime Prevention through Environmental Design audits to identify what physical changes or crime prevention initiatives can be undertaken to reduce the opportunity for crime.

Potential crime prevention initiatives include:

- The pruning and lifting of trees and shrubs to increase natural surveillance by reducing hiding places and creating clear site lines.
- Installing signage to assist users with reporting hazards and required maintenance and repairs.
- Installing or increasing lighting in areas where it is viable and not deemed to increase anti-social behaviour.
- Installation of fixed or short term CCTV cameras can be installed in public places where recommended by Police - in areas where it is viable, and there is significant criminal activity occurring and risk to users.



• Police paying extra attention to areas when resources permit.

With regard to the at risk locations we have identified as a result of the syringe collection data we have collated, we will:

- Install signage where it does not already exist, informing users how to report any hazards
- Undertake additional, or new CPTED audits at sites where no recent audits have been undertaken to assist with determining whether any addition crime prevention initiatives could be undertaken
- Forward our updated at risk locations list to SAPol's District Policing Teams for their information and investigation and with the aim of working with them on potential prevention initiatives.
- Forward our updated at risk locations list to staff and ask that they are extra vigilant in these areas.

McLaren Vale Character Preservation District - community meeting

When the State Planning Commission reviewed the Act and Character Preservation District in 2018, we were pleased that they recommended retaining the legislation for the continued protection of the District. As we've heard, they also recommended to investigate the merits of eight requests for amendments to the Barossa and McLaren Vale District boundaries and the mechanism with which to do this.

The requested amendments for our area are the expansion of the township boundary at McLaren Vale and changing Yaroona from 'rural' to 'township' to reflect its longstanding Township Zoning. It's the requested amendments for McLaren Vale that raise particular concern for us.

At the very first meeting of this current Council on 11 December 2018, Council resolved that it does not support any changes to the Act, it does not support any changes to the urban boundary including any expansion of our townships, and we don't support any further reviews because we believe our residents and landholders deserve certainty.

In undertaking this Review, the Commission must, and is, having regard to Greater Adelaide's land supply and demand for housing growth for the next 15 years, and as we understand it, the Commission's position is that there is an adequate provision of land. Land supply and demand has been the 'first test' for the Commission and based on their testing, there should be no need to consider altering the CPD boundary for more housing in Onkaparinga. Through the Commission's 'testing' process, we believe the expansion of the McLaren Vale township boundary is not warranted. Council's Elected Members will be considering a report on this issue at its 20 July Council meeting, where I suspect our position will continue to be that we do not support any change to the boundary of the McLaren Vale township. The community should be fully informed in detail about what the governments intentions are.

I encourage everyone to provide their feedback to the State Planning Commission through the public consultation process, which closes at 5pm on the 30 July 2021.

NAIDOC Mayor's Reception

Wednesday 7 July was an amazing day as we recognised National Aborigines and Islanders Day Observance Committee through our Mayor's Reception at the Hopgood Theatre, with the theme 'Heal Country'.

The event was powerful as we heard from Senior Southern Traditional Owner Karl Winda Telfer and his nephew Karno Kari Martin, Nyun-ki-burka Me-cow-wee, the Senior Woman of Water and southern country, Aunty Georgina Williams, Susan Roberts-Williams, Doug Clinch Jr, Nellie Egan, and Eddie Peters as they discussed the meaning of NAIDOC and 'Heal Country'.



The responses and discussion were insightful and wise and helped us to reflect on the theme of 'Heal Country' and what that means for us. Susie Roberts-Williams and Jannaya Williams presented beautiful clay artwork that has toured schools and community from last year, Yellaka also performed an awe-inspiring storytelling dance, and Kahl Wallis finished the event performing several powerful songs.

Thank you to all involved in delivering such a wonderful event for our community.

Reception at Government House to honour the Birthday of Her Majesty The Queen

I was very grateful to have been offered the privilege to be hosted by our wonderful Governor His Excellency the Honourable Hieu Van Le AC and Mrs Lan Le at Government House to celebrate the birthday of Her Majesty the Queen.
