## 5.1 Mayor's Report 1 March 2016

## Seaford ambulance station

At the time of writing this report the following was the latest update regarding the Seaford ambulance station.

Many meetings have been held between our staff and those of SA Health to discuss and examine all possible eight sites for the proposed ambulance station at Seaford.

You would be familiar with all the previous background and with the decision that all parties (including Country Fire Service (CFS)) agreed that co-location on the Seaford CFS site was the best alternative. The latest in negotiations is the CFS has requested an exit and ingress controlled lights on Seaford Road because of the age and speed of their vehicles.

#### **Asylum Seekers**

A letter at attachment 1 from the Hon Zoe Bettison MP, Minister for Multicultural Affairs indicates the State Government has agreed to an opt in for South Australia for eligible visa holders. This means those found to be genuine refugees will be able to continue to work, live and study in South Australia.

#### World Heritage Bid

The steering committee and working groups continue to work towards some positive outcomes for this bid. We have considered a very draft application form for National Heritage Bid recently to help the committee delineate areas of research gaps. We also conducted a workshop on work being done by Adelaide University on the agricultural biodiversity and culture project.
