5. Mayor's Communication

5.1 Mayor's Report 28 July 2015

Meeting with Minister Brock

The CEO and I had an opportunity to meet with Geoff Brock, Minister for Local Government and Regional Development on 7 July 2015. The Minister was very generous with his time, being with us for five hours. This extended visit gave us an opportunity to talk him through a range of updates of Council activity, especially where his support and advocacy would be useful as well as showing him some of our region.

Topics covered were:

Noarlunga Regional Centre (NRC) and McLaren Vale Tourism accommodation initiatives

We particularly requested the Minister's support in taking up our case for land release around the railway station with the Hon Stephen Mullighan, Minister for Housing and Urban Development. This is essential to ensure a holistic NRC development. He has committed to following this through.

• World Heritage Bid Program

We discussed the history of this project thus far and expanded on the areas of advantage such a bid holds for tourism and agricultural value add in our region. We requested he speak to the relevant Ministers in government to attempt to change the lack of State support we currently have for this initiative.

Sellicks Beach sewer proposal

We gave Minister Brock all relevant background history to the issue of the need for infrastructure to support sewer delivery at Sellicks Beach. As you are aware the key to our ongoing negotiations is how to best deliver a win:win by achieving sewer connection but at the same time getting additional water for agriculture. The Minister committed to speaking to the Hon Leon Bignell, Minister for Agriculture, Food and Fisheries about this issue.

Local Government Act review

LG (Accountability and Governance) Amendment Bill tabled in Parliament.

Attachment 1 is the Minister's second reading speech. As is clear from this speech this amendment is 'rats and mice' and not driving any major reforms. Late next year is the timing for a more substantial reforming piece of legislation.

My view is we should set up an email logging system so all elected members can log issues as they arise and we can then formalise a response to reform after workshopping all the list.

· Rate rebate to community housing sector

As you may also be aware there has been a change of direction from government on this where we were given advice that the rebate would no longer be mandatory and they have since reneged on that statement. This leaves Local Government again facing major rates loss into the future. Attachment 2 is a question and answer by Minister Rau on this issue.

Coast Park

We raised with the Minister our concerns that this project, originally started by State Government, now appears to not be secure in relation to 50:50 funding. Once again, this will leave Local Government holding the can for what was a State initiative unless we just say 'no thanks, you withdraw funds, so do we!'

NAIDOC celebrations

I was pleased to hold my annual NAIDOC Mayor's Civic event during NAIDOC week.

This year we featured Cultural Connections, a group of young women working together to improve their outlook and future and they catered for the event (delicious). We also featured the Wirreanda School students "In Defence of our Homelands" ANZAC exhibition where each student researched an Aboriginal digger and produced an exhibition of each of their lives. I am expecting this exhibition will appear in libraries for more to see.

Metropolitan Local Government Group (MLGG) meeting

This meeting was held on 8 July 2015.

 Reports included an update on the economic development think tank first forum and media associated with this think tank and an unabridged version of the notes taken. As one of MLGG's three key priorities for the year, our work in economic development is being informed by both the China work/strategy and the think tank.

Included at attachment 3 is the MLGG media released after the think tank. It was agreed that MLGG hold an economic development forum in August 2015 building on what work has already been done.

- Priority two is the metropolitan cycling strategy. The draft strategy to date is concentrating on cycling route priorities, funding opportunities and education programs.
- Priority three is planning reform and precinct planning guidelines. A planning
 reform technical advisory group is working closely with the Local Government
 Association staff around the legislative program for planning reform. They have
 met three times to work through the Terms of Reference, DPTI partnerships and
 implementation program of reforms, engagement of MacroPlan to compile a
 Regulatory Impact Assessment. They are also identifying cultural and practice
 barriers that may block the implementation of planning reforms. The Local
 Government Association Executive is acting as a planning reform strategic
 advisory group also.

The precinct planning guidelines project is progressing with work by the consultant Helen Dyer. The project scope is designed to answer two key areas "when should the precinct planning model be used and what is Council's role in the precinct planning process?"

Rate capping

David Spiers MP, Member for Bright introduced an inquiry in Parliament into rate capping. Council has prepared a submission to the inquiry and it is included at attachment 4.

Federal reforms

- Reform of the Federation program is well advanced with an expected green paper release late 2015.
- Reform of Australian taxation system discussion paper has been released and a white paper is expected early 2016.

Local Nuisance Bill

Here comes another responsibility shift – this time from the Environment Protection Authority to Local Government for local or community nuisance. The Bill will go to Parliament before the end of 2015 - hope we get some of the funds returned from our waste levy to police this one!

Local Government Association

There has been some councils recently questioning what the Local Government Association does for its membership costs. I have included a summary sheet from the LGA for your information. Attachment 5 refers.

Noarlunga Hospital and Transforming Health

I received a letter from the Hon Kyam Maher MLC, Acting Minister for Health advising that the Noarlunga Hospital is here to stay. Please refer to attachment 6 for further information.

Economic growth/unemployment

As South Australia received the disappointing unemployment statistics of growing unemployment, the Hon Martin Hamilton-Smith, Minister for Investment and Trade has appointed Rob Chapman, Adelaide Crows Chairman to lead a \$15 million investment fund body aiming to grow SA jobs. The media release is included at attachment 9.

Financial Assistance Grants to Local Government

Mayor Troy Pickard, President of the Australian Local Government Association, has written to me asking for our Council's assistance to restore the indexation of Financial Assistance Grants and to address their adequacy. I have also received a letter from The Hon Warren Truss MP, Deputy Prime Minister which provides background information. Please refer to attachment 10 for a copy of the correspondence.

As discussed as part of the financial planning and budgetary process over the past few years, indexation on Financial Assistance Grants (FAGs) funding from the Federal Government is currently frozen until 2017-18. Council are due to receive approximately \$8.2m of FAGs in 2015-16, had this amount been indexed at 3 per cent a further approximately \$250,000 would have been received. The freezing of FAGs indexation therefore places significant pressure on councils budget.

As such in order for Council to show their support of this Australian Local Government Association campaign, the Australian Local Government Association have proposed recommendation 2, 3 and 4 below be passed by Council. As we are already required to report funding provided by the Federal Government as

Commonwealth grant funding in council publications, complying with resolution 4 has no additional impact on council resources.
